Merchandise is sold F.O.B. nearest Company warehouse. Upon delivery to the Purchaser or its agent (which include delivery to any carrier at the nearest Company Warehouse) of all or any portion of the merchandise, the Purchaser assumes all property taxes, assessments and risk of loss or damages to or by the merchandise so a delivered. (b) The Company shall not be liable for delay or failure to perform its obligations resulting directly or indirectly from acts of any governmental authority; accidents and disruptions, including but not limited to fires, explosions, breakdowns of essential machinery or equipment and power shortages; transportation or storage delays; labor difficulties; and failure or delay in its usual source of supply. In addition to such causes, the Company shall in no event be liable for delay or failure to perform resulting directly or indirectly from any cause which is beyond its reasonable control. In the event of any delay or failure by the Company to deliver all or part of the merchandises as a result of any of the aforesaid causes, the date of deleyed merchandise shall be extended for a period equal to the time lost by reason for the delay, as determined by the Company. However, if in the opinion of the Company the delay shall exceed 90 days, the Company manu, at its option, terminate its unexecuted obligation.
